“Art in the Park ... Easton”

“Art in the Park...Easton” is taking place at Idlewild Park on May 12, 2012, Saturday from 10 am to 5 pm. This is the second year for this show. Talbot County Visual Arts Center is the hosting organization. The show is located in a beautiful park like setting in a charming neighborhood of Idlewild Park. There will be extensive publicity for this show and hoping for a large turnout of shoppers. Both Talbot County Art Council and Maryland State Arts Council helped to provide funding for this event.

We invite you to apply to have your artwork juried for presentation at “Art in the Park...Easton”.

The Jurying Process:

Jurying will be based solely on images that are provided with the application. The committee of jurors will have final decision. Inquiries questioning or disputing the juror’s decision will not be answered.

Three digital images (photos or CD-Rom) from the applicant will be reviewed by the jury. Make sure those images are the best examples of work that are going to be shown at the festival. All work must be 100% done by the artist. The acceptance into the show will be based on originality, technique, design and overall impact.

Complete this application and mail it to: Talbot County Visual Art Center, PO Box 3214, Easton, MD 21601. Payment must be received with each application. See the application form details.

Art in the Park Rules for Participation:

All items displayed and sold must be designed and executed by the accepted artist. If any items on display are deemed not to be original artwork the festival has the right to remove the vendor from the show. No refunds will be given in this situation. Items on display must be consistent with the images received. In event the artist does not meet these rules and is asked to leave “ART in the Park...Easton” is not liable for lost profits or travel expenses and will not be invited to show in future shows.

Fees:

Booth fees:

Single booth: (10’x15’) \$50 (you bring your own tent)

Double booth: (20’x15’) \$100

Under tent with snow fence \$75 (large tent provided by TCVAC)

All fees are to be included in the application. Please pay by check or money order to Talbot County Visual Arts Center. A service fee of \$25 will be assessed on any returned checks.

Artistic presentation:

All applications must include 3 images that accurately represent your artwork. They must be submitted in one of the following 2 formats.

- CD-ROM with digital images in jpeg format no larger than 3 MB each. CD must be clearly labeled with artist name.
- Photographs 4”x6”, clear images of artwork
- All images must accurately represent the work you will be exhibiting at “Art in the Park...Easton”
- Art forms that are being accepted: paintings (oil, acrylic, watercolors) drawings, pastels, graphics-artist pulled prints only, photography, ceramics and pottery, sculpture, woodworking, weaving, jewelry, felting, textiles, glass, leather and other fine crafts. No gliclees.

Time line:

April 21, 2012 - all applications must be posted marked by this date

May 12, 2012 - unloading starts at 7 am

May 12, 2012 - show runs from 10 am- 5 pm rain or shine

May 14, 2012 - break down starts at 5 pm

Rules and Terms

1. All exhibitors must abide by the requirements as set forth in this application. Those exhibitors who do not display items depicted in their images submitted to the jury may be asked to leave. In event this product and/or the vendor is removed from the show the artist will forfeit his/her booth fee. Talbot County Visual Arts Center and Talbot County Arts Council and its representatives shall not be liable for lost profits or consequential or incidental damages including, but not limited to: travel, lodging, insurance or wages.

2. Exhibit spaces are approximately 10' by 15'. Exhibitors and their belongings must stay inside these boundaries.

3. No specific booth locations are guaranteed.

4. Exhibitors must be set up and ready to show by 9:30 am and remain open until specified closing time unless notified by staff.

5. All booths should be secure and stable in construction.

6. Display booths and items left in place before, during or after the show hours are full responsibility of the exhibitors.

7. Exhibitors must display their "Art in the Park...Easton" identification certificate in the front of their booths at all times.

8. All exhibitors must display their resale tax certificate and is the sole responsibility of the exhibitor to pay sales tax to the state of Maryland and will comply with the terms and conditions stated herein.

9. The Arts Council and Visual Arts Center is not responsible for any damage, loss of personal property, personal injury or accidents involving exhibitors and their personal. Exhibitors indemnify and agree to hold the council and the center harmless from any and all claims, liabilities, demands, lawsuits, costs, penalties, expenses (including attorney fees) and judgments due to breach of this agreement by exhibitors or their personnel.

10. This informational brochure and the application form contain the entire understanding of the exhibitor, TCAC and TCVAC. There are no other promises or representations. No changes shall be binding unless in writing, signed by the exhibitors or member of the "ART in Park...Easton" committee.

11. Failure on the part of the exhibitor or TCAC/TCVAC to complain of any non-action on part of the other, no matter how long it continues, shall not be deemed a waiver, then or thereafter, Any rights under this agreement arising out of the operation of the exhibitor's business during the festival
